# Reflective Home Address Signs

In the case of a fire or medical e mergency, easily readable address signs can cut minutes off response times and possibly save lives. The green or blue reflective



signs can be seen easily day or night by emergency responders. Even if not all the neighbors have address signs, it can help identify houses between existing signs. Seconds matter in an emergency. The Leavitt's recently added a house number sign to a post by the end of their driveway. One can order a sign like this on Amazon for \$14.57 with free shipping. A 4x4 post was used to mount this one, but you can use a metal post, tree or existing fence post. Mounted this way the numbers are visible from both directions on the adjacent road.

## Replace your mailbox with a larger one

Why would anyone want a big mailbox? It turns out there are several good reasons. First and foremost, it can hold many packages that won't fit in a normal mailbox. If you are like many of us in Carriage Hills, you probably order a lot of things online. Many package delivery services now hand their packages off the local Post Office for final delivery. The Post Office will try to put packages in your mailbox, if they fit. Otherwise they may hang them in a sack from your mailbox or leave them at your door. Neither of these is a good option. With our high winds your package can end up down the road and thefts from doorsteps are increasing. Another good reason for a large mailbox is when you're out of town and forget to stop your mail, or if you're the type of person who just gets a lot of mail. If you

have a home business you may not need a Post Office box. So give it a thought:



maybe a bigger mailbox would make sense for you.

### Fish Creek Road Repair Project Wrap-up

"Fish Creek...will it ever be done?" The answer to that question is: someday.

For all practical purposes the work is complete with the exception of a few minor items needing to be done over the coming months. The good news is that there will be little or no inconvenience to the residents. Those items are of course connected to money. Rusty McDaniels at Larimer County Engineering said they are trying (read "no guarantees") to find funds from the state and/or Larimer County to chip seal the entire roadway

to provide a uniform finish to the road. All replacement paving is in place as is the walking/biking trail. What's paved is paved, what's gravel will stay gravel.

There will be a few minor construction activities during the summer months to do repairs or adjustments to the project. Vegetation landscaping is planted and in place, however, due to its nature it will take some time to determine if it is taking hold as planned. This may take a couple of years and could require replacement, moving or removing items.

#### **Current Weather in Carriage Hills**

On one of those super windy days you might ask yourself, "So how windy is it really?" Of course you want to know about the wind right now here in Carriage Hills. With all our open space it could be much higher here than elsewhere in the valley. It turns out that several people have personal weather stations in Carriage Hills, and those stations are plugged into the internet through Weather Underground. Do a Google search on

"Estes Park Carriage Hills Weather" and you will find at least 5 personal weather stations currently online with up-to-the-minute weather statistics, including wind speed and direction.



# **Code Compliance in the Estes Valley**

The Estes Park Code Compliance Department staff oversee all Community Development code compliance activities in the Town of Estes Park and the surrounding Estes Valley. They strive to obtain voluntary compliance with adopted codes through education, cooperation, and enforcement to maintain a safe, healthy, and clean community. Common topics addressed by Code Compliance include: number of vehicles on a property, accumulated

waste materials and rubbish, noxious weeds, vacation rentals, noise levels, home businesses, zoning, setbacks, and building permits.

For at least 15 years, many of the residents who live in the vicinity of the Scott Ponds have scoured the open space around the ponds for litter. During winter, when the strong winds blow, many unsecured items and litter find new resting places in this wide open area. The annual spring cleanup gives us a chance to pick up all the accumulated debris and restore the beauty of the area. Plus it's a fun time to socialize and connect with your neighbors.

For 2018 we would like to extend this effort beyond the Scott Ponds open space to include roadways in Carriage Hills. The Estes Park Recreation and Park District will provide: (a) bags into which litter can be placed, and (b) a truck that will pick up bags of collected litter for disposal.

At this time we're looking for volunteers who are tentatively interested in participating (recognizing that this is early and we don't yet have a date selected for the event). # **Estes Valley Watershed Coalition Plans For 2018**

The Estes Valley Watershed Coalition (EVWC) has completed 14 flood recovery projects, bringing over \$4 million of restoration and recovery dollars to the Estes Valley. Projects were implemented along Fish Creek, Fall River and the Big Thompson River. EVWC completed 3 projects along Fish Creek (Cheley Camp, Upper/Middle Fish Creek and Lower Fish Creek). Fish creek received over \$1.5 million of project funding through the EVWC. These funds were used to protect property and infrastructure, reconnecting



the floodplain, removing sediment, bank stabilization, increasing aquatic habitat and revegetation.


During 2018 EVWC will begin monitoring and maintaining these projects. They will be looking for volunteers and pursuing funds to ensure long term effectiveness of these projects. EVWC will continue with annual stream cleanups, revegetation efforts and connecting our projects to the surrounding area. # Store Trash Properly

Larimer County recently passed a Wildlife Protection Ordinance, similar to the one that the Town has had in place for over a year. The main impact on Carriage Hills is that all residents will now be required to use hard sided garbage containers, even those with bag service, for any trash that could attract wildlife. # What is a Local Telephone Call?

When you get an out-of-area telephone call, do you answer it? Many people don't answer calls from area codes outside Colorado (970 or 303), unless they recognize the number. But area codes aren't what they used to be. Robo calls are a constant nuisance and often come from fake numbers that look like they are local. Then too, many new residents keep their old cellphone numbers after they move to Estes Park. They may not have a local land-line at all. Many

long-time residents aren't accustomed to receiving local calls from area codes all over the country. Some of us on the CHPOA Board have out-of-area phone numbers as well. It can be hard to reach residents if they don't answer our calls and don't have voicemail. Our advice: answer those out-of-area calls (you can always hang up if it's a junk call) or at least have a voicemail box so that you can screen calls and important messages can be passed on to you.

# Dog Reminder

There has been an increase in complaints concerning picking up after dogs when taking them on walks around Carriage Hills. Please be safe and have your dog on a leash and please be prepared to clean up after them. # Dealing With Voles By Don Fredrickson

Voles are small rodents measuring 4 to 8 inches, are brown or gray, with pudgy blunt faces and small eyes and sometimes inconspicuous ears, short legs and short tail. Found in moist meadows and valleys with thick grass, lodgepole pine stands, from 6000 feet to above timberline.

Voles often damage lawns and golf courses and neighborhood yards by constructing runways and burrow systems. Safeguarding gardens and trees can be done if you are willing to encircle young trees and shrubs with ¼ inch mesh hardware cloth 3 to 6 inches below ground and 18 inches above ground.

According to the Colorado State University Extension service, there is little one can do to eliminate the precious little creatures. Voles are classified as non-game wildlife in Colorado and may be captured or killed when they create a nuisance or cause property damage. I have

tried a couple of things: Repellant from Home Depot (about \$13.00) with some success. Mouse traps (baited with peanut butter) work with average success. After calling and hearing some prices (\$100 + per visit) without warranty of success, I decided not to go in that direction. Predator odors, such as the urine from red foxes and coyotes, also may be effective. They may wash off during rain and must be reapplied. Be careful and aware when using poisons as they may be hazardous to pets, other wildlife and children

The bad news is that you most likely can't get rid of the creatures but the good news is that some seasons are better than others. Good luck with whatever method you try.
