SLASH PICKUP ARRANGEMENTS

Bob made arrangements for a date for Slash Pickup with Adams Tree Service....Date around mid-July. This will coincide with Annual Meeting.

This is the #1 reason that people join. Discussion again whether to offer incentive for slash pick up by restricting it to only dues paying members. We would use offer the service to members only with a color code or sign on their slash pile. However, these could blow away or get lost in a storm. Don questioned the cost to pay for the slash pickup service, about \$5,000

Bob suggested considering slash pickup a service to the neighborhood - fire hazard reduction. Trying to identify member's slash piles vs. non-member piles could be more complicated and more work than it's worth. Each year we give a list of member addresses to the contractor but his workers ignore it and just pick up all the piles. It was decided to keep as is.

Two board members took calls and emails for questions from Carriage Hills residents this year, Bettie Tully and Don Fredrickson. Don said a couple of requests a week came in approximately. If the question was clear it was easy to answer them, but not always clear

Bob wants to rotate this job monthly and prepared a "How To" reference document of possible questions or issues and the procedures to respond these.

He stressed it is important to get back with the person initiating the inquiry promptly, even if you don't have an immediate answer.

NEWSLETTER AND TOPICS

Bob wants to reduce the work involved with the newsletter. He has come up with "Mailchimp" as a format to replace the previous newsletter.

Kim and Debi will take up the duties of the newsletter and organize the content. Bob offered to show Kim and/or Debi how to do this with the June letter.

Each newsletter currently costs \$100 to format and about \$480 to print and mail to those for whom we don't have email addresses. Approximately 200-300 residents don't have email addresses.

The majority of newsletters are emailed. We hope to increase the number that are emailed in the future.

In the future, newsletters will be mailed out once a year (in June) with the form and envelope to mail in dues. The rest of the year it will be emailed only to those for whom we have email addresses.

David Born offered to stuff envelopes. Kim also offered to stuff envelopes as well.

Bob wants to have Debi bring the membership database up to date before doing the June newsletter. The newsletter will go out in late June or early July.

The newsletter is to come out twice a year...January and June.

Help will be needed with preparations...utensils, plates etc and coffee or tea. We must provide coffee or tea in on our own containers and the kitchen can't be used. Usual attendance is about 40.

The business meeting will be first. Then Bob's presentation.

The GID Update...it was suggested to ask Christian Lopez to do this for the Annual meeting.

Bob also would like Debi to be able to make changes on to the membership spreadsheet. We talked about adding a LAST UPDATE FIELD for membership records. This might help to track changed records when updating the list in Mailchimp. Debi had some concerns how to accomplish this, so we decided not to do it.

NEIGHBORHOOD CLEANUP RESULTS

Bob asked about the Neighborhood clean up as he was out of town David is planning to do an article on cleanup for the newsletter.

TOWN GOVERNMENT ISSUES

Bob will cover this topic. 588 residential vacation rentals are allowed under the Estes Valley cap. And this cap has been reached. Carriage Hills has about 60 vacation rentals.

CONTACTING NEW RESIDENTS

Mike was interested if there was any positive feedback from his mailings to new residents. Don expressed he had no response. David expressed some positive feedback from those he hand-delivered. Still it was decided to continue doing this. And bring it up at the next business meeting.

OTHER TOPICS

Homeowners association state license renewal. Another bill to be paid by Debi, as the Treasurer is to get the HOA license renewed. Bob will pass along the info to Debi. Debi was not aware of this bill being due. It is \$10 and was due a couple of months ago. It just looks like the HOA isn't active if it is not paid, so no big deal.

DOG POOP DISPENSERS ALONG FISH CREEK TRAIL

Bob Rising wanted bags dispensers for dog poop installed.

DJ was in contact with someone from Parks and Rec many times.

Then Bob R. seemed to back off of this being done, not sure why.

People take the bags, or use them and leave the bags on the ground. Also someone has to refill the dispensers. It was decided not to pursue this as a CHPOA project.

INCENTIVE FOR PAYING DUES ON TIME \$5 REDUCTION

Decided to leave dues at \$30. It makes finances more complicated and more work for the treasurer.

INCENTIVE FOR CULVERT CLEANING

As an issue this has run its course. Bob wants to let this go If needed there is a person who can be recommended (Griffith Excavating).

TREASURER'S REPORT Debi Stalder

Beginning balance 1/1/2018 19,348.77 Balance for May \$24,032.75

With the expenses for slash pick up to be paid from that (\$5,000) coming up in July

2 bills were paid..both for the newsletter

We have 174 paid members with 4 additional ones coming in. This generated 178 x \$30 = \$5,340. This is close to last years memberships

More residents will be paying next month with the annual meeting and the newsletter coming out with a reminder about slash pickup.

Bob handed out some lists he compiled, including CHPOA Functions and How To Run CHPOA.

Meeting closed with bob leavitt saying he will stay on next year as president, if he could get help, support. Many Thanks Bob.
