Bill brought up the issue of beetles...if it has resolved Bob thought so, but Bill said he just lost a tree because of Bob asked Bill to look into this. Kim suggested to put in the newsletter or at Annual meeting

There are some new expenses such as Mail Chimp, and the newsletter postcards. Bob hoped these are manageable expenses. He will look into a discount if 3 years paid for at a time for website hosting. However that would make a larger chunk due every 3 years

Debbi is doing a great job processing dues payments and keeping the membership database updated, but she would like some help in the coming year.
